After the time of leaving the office, it will not carry any weight or significance as you make the payment or register. The most important thing is the address where you want to make the payment and registration, be it the bank of the person making the payment, your bank account, where you will make the payment online or the SBI Remit. Use this information for all kinds of registrations or payments- registration of the scooter, registration or de-registration of the vehicle, registration of new vehicles. SBI Remit: Registration Fee The basic details you need to know Consider that you are in the city of Mumbai and the records from the RTO is the closest record. It can be from SBI, your bank, your supplier of vehicles or even a person who is going to give you the service. SBI Remit also has a business plan of registering vehicles for sale online, according to your requirement. Important details you should keep in mind If you want to register a vehicle online, the SBI Remit will usually ask for the details of the vehicle, like registration number, year, name of the vehicle, registration number of owner, the locator plates, mileage of the vehicle, color, chassis type, and so on. This is all to prove your right to the vehicle. If the registration is for the vehicle you want to purchase, you can provide these details to your vehicle dealer. But the dealer will still request a lot of information, like proof of ownership, proof of identity, driving license, proof of address, ownership proof of vehicle, in case you are in the city of Mumbai. You will have to provide the proof that you are the owner of that vehicle, but that might be a difficult thing, in case you are not the original owner.
